County Councillor Bryan Lovegrove reported:

- There is nothing specific from this Parish that has been raised with county
- The public consultation for the Local Transport Plan 4 is underway. There is a pilot project exploring the demand for responsive transport run by Fox Connect in Market Harborough. If successful, this could be an option for rural communities in the future rather than total reliance on the standard bus service
- The new schedule, starting in October, for the Waste sites around the county has been published and Bottesford will open 3 days a week
- Work on the NEMM distributor road is continuing 7 days a week to try to catch up with the backlog due to poor weather
- Schools are open for registration for the next academic year

Cllr Hulland had a response mid-August reference the bus shelter. This was a holding response and the PC has yet to receive any new information.

#### MOP1 raised 3 issues:

• There are still issues with the application at Cedarwood in Thorpe Arnold. Householders were not advised of the discharge conditions, the tree survey is inaccurate, there is a major problem with the sewage system and there has been no response from Severn Trent about how the vacuum system will cope with additional demand.

There are 9 nest boxes around Waltham. The first swifts were sighted on the 25<sup>th</sup> April and the last sighting was on the 30<sup>th</sup> July. There are several nesting sites, but none yet in the boxes. There seem to be more this year, up to 20 at a time have been sighted. The bird box camera has been tested successfully. Bird boxes will be inspected by the Leicestershire and Rutland Trust later in the year.
